	 New terminology to be used by all agencies when cancelling attending resources. Confirmation required that all persons are out of the vehicle. No longer any need to consider extent of entrapment.
	 Response time requirements updated. Inclusion of a 'remote area' classification and greater clarity given to response time determinations when providers are moving across urban and rural zones.
	Greater reporting requirements when RCR providers are not available.
